### **TOP 10 "UNMET" ACCREDITATION REQUIREMENTS**

## Accreditation inspection outcomes (ED 2017 -2020)

The QIP reports for all EDs inspected between January 2017 and June 2020 were used to collate data on the requirements that were unmet at each inspection.

It may be useful to assists sites in preparing for a site accreditation inspection.

#### Key points:

- Over the time period (Jan 2017 June 2020) 106 regular ED sites accreditation inspections were conducted (not including SSP), of which 40 sites passed outright, and 66 sites failed to meet one or more requirements. A total of 354 unmet requirements were listed against these 66 sites, representing approximately 5 unmet requirements per site.
- There was a total of 354 unmet requirements across these 66 sites.
- Just over 50% of all instances of unmet requirements (178 out of the 354 total) were accounted for by just 10 requirements as listed in the table.
