

Mental Health Strategy and Plan

1. Foreword

Across Australia and Aotearoa New Zealand, demand for mental health services is increasing year-on-year, yet there are too few services to meet community need. In the absence of these services, emergency departments (EDs) are the only access point for many people to the mental health system.

Our members working in EDs report, and our data confirms, that patients presenting to EDs for mental health care routinely experience excessive and unreasonably long waits often in inappropriate and, at times, unsafe environments. It is a constant challenge for ED staff to find a safe path for patients such as admission to an inpatient bed or home with appropriate community supports in place, particularly when someone is experiencing a crisis. The current mental health system planning, coordination and accountability mechanisms are failing. These dangerous delays and negative experiences are an indicator of widespread system failure across acute psychiatric and community-based mental health care, damaging to people who need care, and stressful for staff working in EDs.

In October 2018, the Australasian College for Emergency Medicine (ACEM; the College) convened the national Mental Health in the Emergency Care Summit (the Summit). The Summit brought together over 170 experts in recognition of the vital role that EDs play as part of the mental health system. The Summit was the catalyst for a range of mental health-related activities across the entire College in the past three years. The Summit delivered the Mental Health in the Emergency Department Consensus Statement calling for new models of care across the mental health system, including for the management of urgent care needs and for discharge and referral. The statement has garnered over 1000 signatures, represented by physicians, psychiatrists, nurses, carers, and consumer advocates, including CEOs for peak bodies for consumers, emergency and mental health nurses, and community health services across Australia.

Following the Summit, the College has published several reports, including the <u>Waiting times in the Emergency Department for People with Acute Mental and Behavioural Conditions</u> and <u>The Long Wait: An Analysis of Mental Health Presentations to Australian Emergency Departments</u>. These two publications have analysed and reported on national research data regarding mental health presentations to Australian EDs.

A third report, titled <u>Nowhere Else To Go: Why Australia's Health System Results in People with Mental Illness Getting 'Stuck' in Emergency Departments</u> was published in 2020. The report analyses why Australia's health system is failing to meet the urgent needs of people presenting to EDs for mental health care, and presented a comprehensive set of recommendations for reform. The report closely examines how funding and governance factors impact on demand for ED services by people experiencing mental health crises, emphasising the everincreasing complexity in people's lives, and the need to build and sustain a functioning, integrated mental health system across the whole spectrum of care.

In June 2019, the College convened a <u>summit in Wellington</u>, Aotearoa New Zealand, which brought together over 80 delegates, representing doctors, nurses, patient advocates and system managers. The Summit delegates considered progress made by the government in response to its Inquiry into Mental Health and Addiction, especially the Wellbeing Budget, which comprises a suite of wellbeing measures intended to raise living conditions across Aotearoa New Zealand.

Delegates at the Summit noted the research data demonstrating the poor experiences of mental health patients and discussed the needs of patients when they were in crisis. The delegates shared experiences of good models of care, innovations in service delivery and discussed the need for investment in resources, people, culture and support, both inside and outside of the ED.

Since these two summits, the ACEM Board has committed to the development of a mental health strategy and action plan, and establishment of a Mental Health Working Group to support it. The Strategy builds on the considerable mental health advocacy ACEM has undertaken in the last four years.

Supporting the mental health of Australians and New Zealanders requires a whole of system approach and this Strategy demonstrates the commitment of ACEM and its members to contribute to that reform.

2. Strategic context

The prevalence of persons experiencing mental illness in Australia, and Aotearoa New Zealand is significant. It is estimated that one in five (20 per cent) people in both countries have experienced mental ill health in the past 12 months. Research data from both countries highlights that the Aboriginal and Torres Strait Islander population in Australia, and the Māori population in Aotearoa New Zealand, are overrepresented in mental health statistics.

In Australia, the mental health sector finds itself in a period of major reform at the national and jurisdictional levels. This reform reflects the release of the Productivity Commission *Mental Health Inquiry Report* in November 2020, the Fifth National Mental Health and Suicide Prevention Plan nearing the end of its five-year span, the Royal Commission into Victoria's Mental Health System, the ongoing Royal Commission into Violence, Abuse, Neglect and Exploitation of People with Disability, and the Commonwealth's <u>plans to overhaul the NDIS Act</u> and <u>implementation of the policy</u>, which funds mental health supports and services for 65,000 Australians.

In Aotearoa New Zealand, improving mental health has been high on the agenda of the current government since its election in 2017. A 2018 report, *He Ara Oranga*, from the Government Inquiry into Mental Health and Addiction identified many priorities, including the establishment of the independent Mental Health and Wellbeing Commission and the reform of mental health legislation, resulting in the Mental Health and Wellbeing Commission Act 2020. These two acts set the stage for significant service level reform, which will need strong guidance from consumers and health practitioners.

ACEM has committed itself to advocating in both Australia and Aotearoa New Zealand for adequate mental health service provision, improved funding and service models, adequacy of rural mental health services, improved workforce capacity, effective services coordination and accountability, and ensuring best practice emergency mental health care and treatment.

ACEM is also committed to ensuring the needs of first nations people, Māori in Aotearoa New Zealand and Aboriginal and Torres Strait Islander peoples in Australia, are prioritised in this important work. As set out in Manaaki Mana and our Reconciliation Action Plan, we will seek practical, culturally safe ways for mental health equity to be delivered in our emergency departments and the community.

3. Our business

ACEM is responsible for training emergency physicians and the advancement of professional standards in emergency medicine in Aotearoa New Zealand and Australia. The goals and actions in this strategy reflect where we can direct our influence through:

- Enabling our members and ACEM staff to better understand mental health and wellbeing through education, training and communication;
- Promoting standards of care through our policies, guidelines and standards;
- Establishing initiatives within our Specialist Training and Continuous Professional Development programmes to ensure our emergency specialist workforce is well equipped to respond to patients experiencing mental distress (including through Accreditation Standards, curriculum and training requirements and ongoing professional development);
- Advocacy to governments to build a holistic, integrated and fit-for-purpose mental health system.

4. Our vision

Advocating for a mental health system where all people have access to the care they need, at the time they need it. A mix of demand management (care in the community) and resourcing EDs to provide acute and urgent care. And no patient spends longer than 12 hours in the emergency department. Ever.

5. Our goals
