#### **Annual Hourly Requirement**

#### » 50 Annual Hours Summary

50 annual hours is made up of: 12.5 hours of Educational Activities and 25 combined hours from the Meausring Outcomes and Reviewing Performance activities, with at least 5 hours each of these two CPD categories, the remaining 12.5 hours can be completed from any CPD category or combination of categories.

#### **Additional MCNZ Requirement**

#### » Annual Conversation

MCNZ recertification standards require practitioners to participate in an Annual Conversation with a peer, colleague or employer about the practitioner's clinical practice. The goal of this activity is to facilitate reflection on developmental and personal needs, professional goals and their intended CPD activities for the coming year.
