# COVID-19 Emergency Medicine Community of Practice (EMCoP)

ACEM is convening the EMCoP for a limited time to facilitate the sharing of information, ideas, strategies, local solutions and concerns with respect to COVID-19 pandemic preparedness and responses. ACEM hopes this forum will provide opportunities for the two-way flow of information between key government decision makers and the emergency care workforce.

ACEM expects EMCoP will convene for 4 to 5 meetings over around 8 to 10 weeks, depending on the interests of participants. It will then be evaluated by participants at this point and either discontinued or transferred to DHHS/Safer Care Victoria.

### 2. Key issues and actions

- PPE and mask types
  - Concerns about whether fit testing will provide enough diverse options, and what will happen where staff are unable to get the right mask
  - o Some inconsistency in guidance across health services
  - Skin care and pressure ulcers, guidance needed on the use of DuoDERM
  - Ensuring equity of access for frontline workers, women in the healthcare workforce and rural areas
- **Transparency of governance structures** a need to increase the EMCoP's access to information about the various DHHS and SCV governance meetings and committees, such as appointment processes and minutes
- Improving communication between the Commonwealth, State government and health services the situation is improving, but there is still poor coordination in areas
- Aged care response moving forward.
  - Need for continuing work to address critical workforce shortages and governance structures that enable planning and coordination on-the-ground.
  - It was acknowledged in the meeting the significant contribution of the Field Emergency Medicine Officers and many hospital level nurses from Victoria in the recent Aged Care response to the

outbreaks of COVID 19 in many facilities throughout Victoria. Many who have been working extremely hard from our their own services.

- **Mental health presentations.** Support is needed for addressing the increase in mental health presentations to the ED and lack of access to mental health beds.
- Ambulance offloading. Delays in ambulance off-loading are impacting service delivery and patient care.
- **Furloughed workforce.** Information wanted on DHHS and SCV response plans for supporting health services where significant amounts of staff are furloughed.
- Workforce wellbeing. Staff are experiencing fatigue, and furloughed staff are experiencing guilt. There has been an increase in occupational violence.
- Health care worker infections. More information wanted on reducing the rate of infections in the emergency medicine workforce.

ACEM will compile a list of issues and actions raised in the meeting for DHHS and Safer Care Victoria follow up before the next meeting. The list and the responses received will be shared with the EMCoP.

- mental health presentations to the ED
- workforce wellbeing.
